Purpose Of Corporation / Déclaration d'intention de l'organisation

The Heather Cutler Foundation is dedicated to providing relief and support to individuals and families affected by pancreatic cancer through a range of services, community engagement, and educational initiatives. The primary objectives of the corporation are as follows:

1. **Relieve Suffering:** Alleviate the physical, emotional, and financial burdens faced by pancreatic cancer patients and their families by offering comprehensive support programs and services.
2. **Advance Education:** Raise public awareness about pancreatic cancer by educating individuals on symptoms, diagnosis, treatment options, and management strategies, thereby promoting early detection and understanding.
3. **Promote Health:** Improve the well-being of pancreatic cancer patients and their families by advocating for their healthcare rights, facilitating access to medical services, and fostering a community of support.
4. **Engage the Community:** Mobilize individuals and groups to take action on issues affecting pancreatic cancer patients. This includes initiatives like our petition to the House of Commons, aimed at increasing access to care, clinical trials, and addressing interprovincial disparities across Canada.

The Heather Cutler Foundation is committed to operating exclusively for charitable purposes as outlined under the Income Tax Act, dedicating its resources solely to activities that support these objectives.

Classes of Members / Catégories de membres

The corporation is authorized to establish Class A members and Class B members as follows:

- (1) The Class A members shall be entitled to receive notice of and to attend all meetings of the members of the Corporation and each Class A member shall have one (1) vote at each such meeting, except for meetings at which only members of another class are entitled to vote separately as a class.
- (2) Except as otherwise provided by the Canada Not-for-Profit Corporations Act, S.C. 2009, c.23 the Class B members shall not be entitled to receive notice of, attend or vote at meetings of the members of the Corporation.

Any property remaining on liquidation of the Corporation, after discharge of liabilities, shall be distributed to one or more qualified donees within the meaning of subsection 248(1) of the Income Tax Act.

Additional Provisions / Dispositions supplémentaires

If authorized by a by-law which is duly adopted by the directors and confirmed by ordinary resolution of the members, the directors of the corporation may from time to time:

- i. borrow money on the credit of the corporation;
- ii. issue, reissue, sell, pledge or hypothecate debt obligations of the corporation; and
- iii. mortgage, hypothecate, pledge or otherwise create a security interest in all or any property of the corporation, owned or subsequently acquired, to secure any debt obligation of the corporation.

Directors shall serve without remuneration, and no director shall directly or indirectly receive any profit from his or her position as such, provided that a director may be reimbursed for reasonable expenses incurred in performing his or her duties. A director shall not be prohibited from receiving compensation for services provided to the corporation in another capacity.

The corporation shall be carried on without the purpose of gain for its members, and any profits or other accretions to the corporation shall be used in furtherance of its purposes.

The directors may appoint one or more directors, who shall hold office for a term expiring not later than the close of the next annual general meeting of members, but the total number of directors so appointed may not exceed one-third of the number of directors elected at the previous annual general meeting of members.
